Professor Levin is an experienced practitioner and trainer in dispute resolution and was a founding member of the National Association for Community Mediation. He served on its board of directors and on the board of the National Conference on Peacemaking and Conflict Resolution and teaches in the Law School's Mediation Clinic.
