For approximately 15 years, I worked with Heyl, Royster, Voelker & Allen's Rockford office. During that time, the Illinois Supreme Court sponsored a pilot mediation program in Winnebago County. During that time, I participated in many mediations and received training through the Alternative Dispute Resolution Center in Winnebago County, which was also sponsored and funded by the Illinois Supreme Court.

Prior to my training as a lawyer, I attended the University of Illinois, receiving a BA and MA in communications. As part of my undergraduate and graduate studies, I took courses in small group communication, problem solving and persuasion. Many of the same principals learned in that field have general application to the mediation process and the building of consensus and resolution. I feel that that experience, coupled with 25 years as a defense litigator, equips me with the experience and tools to assist adverse parties in reaching a resolution of a case through the mediation process.

As an attorney practicing for 25 years, I have participated in over 100 mediations. This experience gives me good insight into understanding the perspective of a party going through the mediation process.

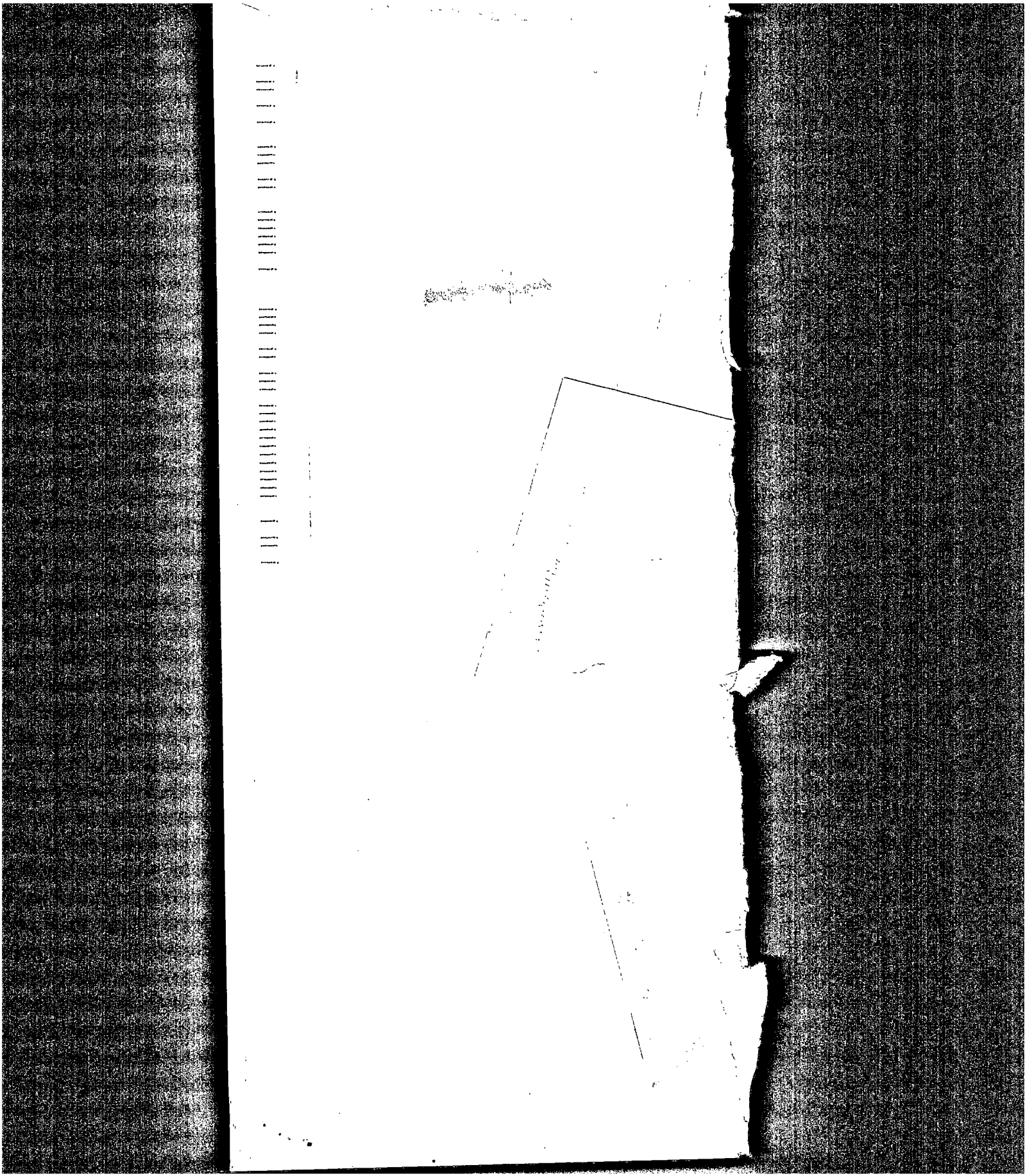

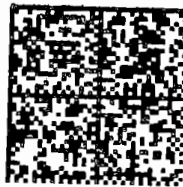
