10. In the space below, briefly describe your experience, qualifications, special areas of expertise, and any other reasons why you should be selected as a neutral.

Since 1980, I have tried more than 40 jury and bench trials lasting at least one week each, representing almost equally plaintiffs and defendants in state and federal courts in Missouri, Illinois, New York and Iowa. I have tried another 30 plus cases of shorter duration, and briefed and argued 13 appeals in state and federal courts. I focus on business litigation and construction law, but have tried cases in many other areas as well. Longer jury trials include a one-month jury trial and five-month bench trial in state court in Benton, Illinois, a nine-month jury trial in federal court in Buffalo, New York, and a three-week jury trial in federal court in Des Moines, Iowa. I focus on business litigation and construction law, but have tried cases in many other areas as well.

I am a neutral with the American Arbitration Association, where I have been an arbitrator on fourteen cases from March 2000 to August 2001, ranging in dispute size from \$10,000 to \$10,000,000. When not in trial, I routinely counsel clients on trial matters, including the merits and the hazards. I also have authored fourteen published articles since 1999, including articles on ADR in *Missouri Lawyers Weekly* (also featured in *Wall Street Reporter*) and *the St. Louis Construction News & Review*, where I serve as its legal writer. I am the program chair for the American Arbitration Association ("AAA"), St. Louis Region, and serve on the Advisory Committee of the Construction Law Section of AAA's St. Louis Region.

I also represent on an ongoing basis clients in matters of arbitration and mediation. Although a trial lawyer, I am an avid, outspoken supporter of ADR, and routinely chair seminars for the AAA on arbitration and mediation to various organizations.

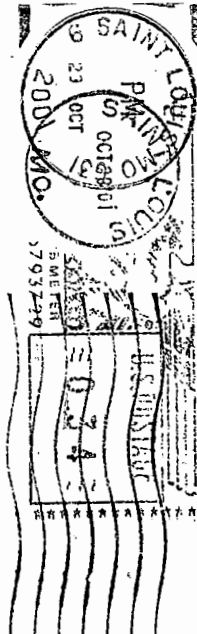
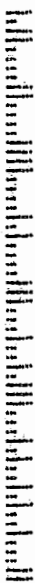
