

I served 14 years as a trial lawyer for the U.S. Equal Employment Opportunity Commission. As an EEOC lawyer, I evaluated cases and presented those cases to the Commission for a decision on whether the facts warranted expending government funds to litigate. If the case was approved, I then litigated it. Prior to working for the EEOC, I defended employers in lawsuits brought by current or former employees claiming employment discrimination. I have been an advocate on both sides of employment disputes. For that reason, I believe I am able to draw upon my experiences in order to better understand why one side or the other has taken the position they have taken with regard to settlement. I have found this to be extremely useful in resolving employment disputes.
