I have completed the training for Civil Mediation at the University of Missouri-Columbia School of Law. I attended the course January 10-12, 2005. I have also attended approximately 40 mediations as a party.

Question 7:

I was employed as in-house counsel for healthcare issues, risk management and litigation management for BJC Healthcare and Sisters of Mercy Health System 1983-2003.

During my tenure managing claims and litigation for the health systems, I often managed the early settlement of claims. As the effective equivalent of the insurance adjuster for the systems' hospitals, I attended approximately 40 mediations in Missouri, Illinois, Arkansas and Texas. I was a hospital risk manager for much of that time, and have held local and state offices in healthcare risk management professional organizations. Risk managers frequently work with patients and families when an adverse event occurs to resolve whatever issues arise from it.

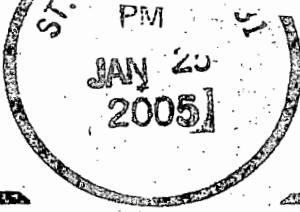
