NOTICE OF STATUTORY CHANGE AND REVISED ST. LOUIS COUNTY SHERIFF'S OFFICE CIVIL FEE SCHEDULE

Section 57.280 RSMo states in part, "5. [...] Sheriffs shall receive up to fifty dollars for service of any summons, writ, or other order of the court in connection with any eviction proceeding, in addition to the charge for such service that each sheriff receives under this section. All of such charges shall be received by the sheriff who is requested to perform the service and shall be paid to the county treasurer in a fund established by the county treasurer, which may be expended at the discretion of the sheriff for the furtherance of the sheriff's set duties. All charges shall be payable prior to the time the service is rendered; provided that if the amount of such charge cannot be readily determined, then the sheriff shall receive a deposit based upon the likely amount of such charge, and the balance of such charge shall be payable immediately upon ascertainment of the proper amount of said charge."

As such, in St. Louis County, Sheriff's service fees will increase on writs, executions, and other orders of the St. Louis County Circuit Court in connection with any eviction proceedings. Fee increases will go into effect on the following dates:

- January 1, 2023 = \$56.00
- January 1, 2024 = \$66.00

This will **NOT** affect service fees of summons in connection with eviction proceedings at this time.
